Penelitian ini bertujuan untuk mengetahui pengaruh Pendapatan Asli Daerah terhadap Belanja Modal, Dana Alokasi Umum terhadap Belanja Modal, Dana Alokasi Khusus terhadap Belanja Modal, Pendapatan Asli Daerah terhadap Pertumbuhan Ekonomi, Dana Alokasi Umum terhadap Pertumbuhan Ekonomi, Dana Alokasi Khusus terhadap Pertumbuhan Ekonomi, Belanja Modal Terhadap Pertumbuhan Ekonomi. Pengambilan sampel dengan metode *purposive sampling*. Subjek dalam penelitian ini adalah Pemerintah Daerah kabupaten/kota se Indonesia, dan objeknya adalah Pendapatan asli Daerah, Dana Alokasi Umum, Dana Alokasi Khusus, Belanja Modal dan Pertumbuhan Ekonomi. Jenis data yang dikumpulkan adalah data sekunder yang bersumber dari Laporan Realisasi Anggaran Pendapatan dan Belanja Daerah pada kabupaten/kota se Indonesia. Data dikumpulkan dengan pencatatan dokumen, serta dianalisis dengan menggunakan *Path Analysis*.

Hasil pengujian menunjukkan bahwa Pendapatan Asli Daerah tidak berpengaruh terhadap besarnya Belanja Modal, Dana Alokasi Umum dan Dana Alokasi Khusus berpengaruh terhadap Belanja Modal, Pendapatan Asli Daerah, Dana Alokasi Umum, Dana Alokasi Khusus tidak berpengaruh terhadap Pertumbuhan Ekonomi, dan Belanja Modal berpengaruh terhadap Pertumbuhan Ekonomi.

## **ABSTRACT**

This research was intended to find out the effect of Own-Source Revenue towards the Capital Expenditure, the General Allocation Grant towards the Capital Expenditure, the Special Allocation Fund towards the Capital Expenditure, the Own-Source Revenue towards the Economy Growth, the General Allocation Grant towards the Economy Growth, the Special Allocation Fund towards the Economy Growth, the Capital Expenditure towards the Economy Growth. This research used purposive sample as the method. The subjects of this research were all districts in Indonesia, meanwhile the objects were the Own-Source Revenue, the General Allocation Grant, the Special Allocation Fund, the Capital Expenditure and the Economy Growth. The used data were the secondary data taken from the Own-Source Revenue Statement in all districts in Indonesia. The data were collected by recording the documents, and analyzed by using Path Analysis.

The test result showed that the Own-Source Revenue did not affect how much the Capital Expenditure was, the General Allocation Grant and the Special Allocation Fund Affected how much the Capital Expenditure, the Own-Source Revenue, General Allocation Grant were, Special Allocation Fund did not affect how much the Economy Growth was, and the Capital Expenditure affected how much the Economy Growth was.
