



Tujuan utama dari penelitian ini adalah untuk menganalisis pengaruh dana alokasi umum, produk domestik regional bruto, kepadatan penduduk dan inflasi terhadap tingkat kriminalitas, dengan studi kasus lima kabupaten di wilayah daerah Istimewa Yogyakarta periode 2008-2014 dengan menggunakan model random efek. Hasil penelitian menunjukkan bahwa dana alokasi umum dan produk domestik regional bruto berpengaruh negatif dan signifikan terhadap tingkat kriminalitas di daerah istimewa Yogyakarta, Sementara kepadatan penduduk berpengaruh positif dan signifikan terhadap tingkat kriminalitas di daerah Istimewa Yogyakarta. Selain itu, studi ini juga menemukan bahwa inflasi pada saat ini tidak memiliki pengaruh yang signifikan terhadap tingkat kejahatan di wilayah Istimewa Yogyakarta. Hal ini dimungkinkan terjadi karena inflasi yang terjadi di daerah istimewa Yogyakarta masih dalam kategori aman karena kenaikan inflasi belum di atas 10% pada setiap tahun sehingga inflasi tidak menjadi faktor dalam tingkat kejahatan daerah istimewa Yogyakarta.

ABSTRACT

The main objective of this study is to analyze the influence of general allocation funds, Gross domestic regional product, population density and inflation of the crime rate in the case of five districts in special region of Yogyakarta period 2008-2014 by using random effects models. The results of this study shows that general allocation fund and Gross domestic regional product are negatively and significantly influence of crime rate in special region of Yogyakarta, While population density is positively and significantly influence of crime rate in special region of Yogyakarta. In addition, the study also finds that inflation is having no significant influence to crime rate in special region of Yogyakarta. This is possible because of inflation that occurred in the special region of Yogyakarta is still in the safe category because of rising inflation has not passed 10% in each year so that inflation has not become a factor in the crime rate special region of Yogyakarta.
