

CHAPTER V

CONCLUSION

Normatively the existence of ethnic and culture differences in every state around the world cannot be avoided by the native. This new condition should be accepted naively by the native because the characteristic and behavior of society has been changed because of the globalization consequences. This kind of condition will appearing the new condition of social kinds, such as the emerging of immigrant as the new comer, refugees as the illegally comers, tourist as the commercial and temporary comers and many kinds of things. Especially for the immigrant, they have purpose to integrate permanently into the society and have equal rights and treatment as the citizen of state.

Because of the globalization consequences, Germany becomes a pluralistic country that actually has some seriously problems about the inequality right and treatment among society. In this case, one of them is the discrimination practices between native as the majority against Turkey immigrants as the minority ethnoculture. Discrimination act that appear is caused by some of basically reason and factor, such as religion and culture. In the discrimination practices, surely the one who will get the physically and mentality lost impacts is supposed to be the minority because constitutionally their representative bodies

and organizations did not strong enough to protect their interest and right in the state.

DITIB is a representative organization of ethnic (Turkish) and religion (Islam) that have the roles and strategies to terminate and decrease the discrimination practices in Germany. The DITIB's role was reflected in their program resolving the discrimination. There are some programs of DITIB, such as the internal and external program. The main point of those programs is to influence and give the government consideration to make the decision and policy about anti-discrimination laws (AGG) and immigration problems (Naturalization Plecy). The role of DITIB is on how they run their strategy by giving the influence to the Germany Legislative body in the decision making process arena until results in the "win win" solution policy.

The new of anti-discrimination laws will help to minimize the discrimination act against minority because the new one of laws will be adapt to the new condition of society environment in Germany, so the laws could be run optimally. In this case, the General Equal Treatment Act (Allgemeines Gleichbehandlungsgesetz, "AGG") is as the new discrimination laws of Germany Government. As well as the Immigrant Naturalization Policy gives the immigrants narrow scope to be a German citizen. So the perspective view of native Germany is not only seeing the immigrant as the newcomer that easily to be a Germany citizen but the newcomer is the individual who wants to blend in and become a truly German citizenship.

By running those kinds of DITIB's programs, the integration expectation can be achieved and discrimination would be decreased even terminated. The main point is that the difference is not the worst thing that has to be ignored and avoided but it should be accepted and gratefully.

On the other hand, The International law inside the International Relations study was emphasized that the discrimination practices against the minority ethnoculture (immigrant) was forbidden whatever the reason was. There were sanctions firmly from the International Court of Justice to the state if they did not enforce the anti-discrimination law in the judicial institutions of state. There were a regulation and social controlling from government to protect the equality of citizenship of state.

In the Resolution Conflict lecture, the form of social controlling was the tool that used by society to maintain the social behavior from the social distortion by using persuasive way. Therefore, social controlling could decrease some of the social distortion like discrimination practices. By correlating to the theory above, the writer conclude that the social controlling can be achieve if there is a good communication between the state government and the representative organization to build the law and regulation.
