Analisa data dengan Teknik Analisa Data kualitatif menggunakan analisa Miler dan Huberman dan Teknik Analisis Data kuantitatif menggunakan Uji-t berpasangan.

Berdasarkan hasil penelitian yang penulis lakukan dalam penelitian ini dapat penulis simpulkan bahwa: (1) Latar belakang munculnya program Diklat Cakep 2015 bila dievaluasi konteks hasilnya cukup baik, (2) Input program Diklat Cakep 2015 bila dievaluasi hasilnya cukup baik, (3) Pelaksanaan program Diklat Cakep 2015 berjalan dengan baik, (4) Hasil Diklat Cakep 2015 bagi Kepala Sekolah dalam peningkatan kompetensinya adalah efektif dan (5) Kegiatan Diklat Cakep 2015 telah memberikan dampak positif bagi Kompetensi Kepala Sekolah yang telah mengikuti Diklat tersebut.
