E-learning is a learning model in a virtual form that enables the students to do the learning process without having to directly meet the teacher. The implementation of e-learning involved the role of lecturers/teachers, students and the ways of learning. English Language Education Department of a private university in Yogyakarta has implemented e-learning in the form of blended learning. This research aims to investigate the advantages and disadvantages of the implementation of e-learning based on the students' point of view. This research used descriptive qualitative as a research design, and used interviews to collect the data. The data were collected from four students of English Language Education Department batch 2017 who have joined e-learning. In addition, the findings show that e-learning has several advantages namely e-learning is a flexible way of learning, e-learning can minimize the budget, e-learning provides more broaded material and e-learning can encourage students participation. Moreover, the implementation of e-learning also have some disadvantages namely e-learning reduces students' direct interaction with other students, e-learning reduces students' direct interaction with lecturer, e-learning enables the students to do cheating, unclear instruction from the lecturer, and e-learning reduces the chance for spontaneity of speaking. Overall this study concludes that the implementation of e-learning might be a good decision if both the students and teacher have a good preparation in conducting the e-learning process.
