#### **ABSTRACT**

The purpose of this study is to examine the direct effect of religiosity, the spirit of nationalism and tax amnesty on taxpayer compliance. This study used the dependent and independent variables. The data is collected by using an online questionnaire (Google forms) survey method, which can be collected for up to 120 respondents and can be used for analysis. The validity, reliability of instruments and classical assumptions test were conducted before testing the hypothesis. Simple and multiple regressions were used to test the relationship between variables. The data were analyzed using IBM SPSS Statistic version 21 tools. The results show that the level of religiosity has a positive impact on the spirit of nationalism and taxpayer compliance. A high spirit of nationalism would increase taxpayer compliance. The results also provided empirical evidence that there was direct influence of all the variables; religiosity, the spirit of nationalism and tax amnesty on taxpayer compliance.
