ABSTRACT

This study aims to determine the effect of human resources and utilization of information technology through organizational commitment as moderating the transparency of village financial management in Bantul Regency, Special Region of Yogyakarta. This study uses a convenience sampling method involving village officials as representatives of the village government. The number of samples in this study were 30 villages in Bantul Regency. The type of data used is primary data. The results show that human resources have a positive effect on the transparency of village financial management, utilization of information technology has a negative effect on the transparency of village financial management, organizational commitment does not succeed in moderating the influence of human resources and utilization of information technology on the transparency of village financial management.
