# CHAPTER ONE INTRODUCTION

## A. Background

The issues of human rights is still the most frequently raised today. Themes were debated across the globe. Almost every day the media report about the people who are being discriminated, tortured, killed, or enforced disappearance of political opponents. The 1948 Universal Declaration of Human Rights (UDHR) is the modern international framework that coveredthe human rights issue. The year 2017 is a dark era for investigators of the Corruption Eradication Commission Novel Baswedan. On April 11, returning from the morning prayer from a mosque near his house in Kelapa Gading, North Jakarta, he was attacked by two unknown people. Using a motorcycle, the two men splashed acid on Novel's face. Investigators in the corruption case of the Electronic Identity Card project must also be rushed to Singapore to undergo healing in the face and eyes. Until the end of 2017, the wounds onthe Novel's face have begun to heal. However, the police did not succeed in finding the perpetrators of the attack.

Various methods had been taken by the police to investigate this case. The police had established a team of hundreds of personnel from the police station, the regional police assisted by the National Police Headquarters. Police also called for help from the Australian Federal Police (AFP) to study CCTV footage. The former Corruption Eradication Commission leaders, anti- corruption activists, media, and human rights activists even urged President Joko Widodo to form a Joint Fact Finding Team (TGPF) to uncover Novel sprinklers.<sup>2</sup> The National Human Rights Commission has found sufficient initial evidence for violations of a number of rights in the case of the Novel. Rights that are violated include the right to security, the right to be treated
