ABSTRACT

Ahead of the 2019 election, PKS was rocked by issues of division, after the arrest of President Lutfi Hasan Ishak by the KPK in 2013, and the number of seats in the DPR decreased significantly in the 2014 election, but in the 2019 election the seats in PKS in the DPR increased significantly. The research entitled PKS Solidity in Facing the 2019 Election aims to determine the solidity of the Prosperous Justice Party (PKS) in dealing with the 2019 Legislative Election. This type of research is a qualitative research that is literature. The source of data in this study is secondary data, namely data from the Central KPU website, election survey institutions, journals, and scientific books that are in accordance with this research. The data analysis technique used is descriptive analysis technique, which explains the phenomenon briefly by going through three stages, namely data reduction, presentation of data, and conclusions. The results of the research show that PKS as a political party is required to be ready to face the national political constellation, especially ahead of the 2019 Legislative Election. In that political year, the solidity of PKS was really tested, especially internally which experienced friction. In general, the solidity of the Prosperous Justice Party (PKS) in facing the 2019 Legislative Elections was concluded still strong, even has internal divisions conflict.
